The three artist finalists were interviewed in order of their respective time zones and schedules: Mark Reigelman, James Angus and Susan Zoccola. They each had 30 minutes with the Artist Selection Panel during which they presented examples of their past work, talked about how they would approach this project if selected, and answered the six interview questions along with any additional questions the panel asked.

Staff then facilitated an in-depth round of discussion, where each Core Team member, Advisor and panelist present was called on and shared their impressions of all three artist finalists and which artists they felt best fit the project; it was clear there was consensus developing around Mark Reigelman and Susan Zoccola, due to their community engagement practices, thoughtful approach to previous projects and overall creativity. The panel liked the color palette and bold sculptural quality of James Angus's work but felt this was not the right project for him. The panel voted by email ballot

The four (4) design team artist-finalists, shortlisted by MIG, were interviewed in order of their respective time zones. Each artist-finalist had approximately 15 minutes to make a visual presentation that addressed questions, provided in advance, related to their experience making durable outdoor public artworks, working in the role of artist/planner, collaborating with other design professionals, and addressing community aspirations. In addition, they discussed their approach to identifying opportunities for diverse local artists as part of the planning process.


Following all of the artist-finalists' presentations, staff facilitated an open discussion in which each selection panelist and advisor was called on to share their thoughts. Although all were impressed with the qualifications of the artist-finalists, a consensus quickly developed around FutureForms and Legge Lewis Legge due to their design team/planning and placemaking experience, as well as their ability to create opportunities for other artists and community engagement. The Artist Selection Panel voted by email ballot, with the first ballot for the preferred artist-finalist and a second ballot for alternate:

FINAL DESIGN PREVIEW



The current Fire Station #26 is seen as a gateway between commercial and residential areas in this community, a feeling the artwork associated with the new replacement building is meant to echo. After spending 50 hours during a microresidency with the firefighters, artist Julie Lazarus learned of the personal importance of the firefighters' helmet and its reputation as a "badge of honor." Her Final Design includes three series of helmets, each uniquely patterned, to represent the various personnel on each shift (A, B, and C) at the station. The arrangement addresses the uniqueness of the station location with artwork viewable from the neighborhood, Hulen Street, and Granbury Road.

The helmets will be a combination of mirrored and brushed stainless steel, each measuring approximately 21 inches height by 28 inches width by 0.135 inches in depth. The work will be lit at night with an ultramarine blue colored light, echoing the color of the firefighters' trucks.

The artist will share further details during her Final Design presentation at the Fort Worth Art Commission meeting on Monday, May 17, 2021.

OVERVIEW

Fort Worth artist Lynne Bowman Craven's design for an artwork for the Municipal Vehicle Maintenance facility at the Holly Water Treatment Plant consists of a series of five sculptures, eight feet tall, that run along the east side of Forest Park Boulevard. These sculptures show the progression of folding an origami scissor tail flycatcher bird, starting from a solid white square all the way to a completed folded form. The scissor tail flycatcher's habitat is specific to Texas, Oklahoma, parts of other southern states and Mexico and it can readily be found along the Trinity River during its breeding season.

BUDGET

There is \$200,000 in funding available from the 2014 Bond, Proposition 6, for an artwork associated with the Municipal Vehicle Maintenance Facility at the Holly Water Treatment Plant; and this Project was identified in the Public Art Plan for the 2014 Bond Program adopted by City Council on October 21, 2014, (M&C G-18339) and this project was included in the Fort Worth Public Art Fiscal Year 2019 Annual Work Plan, adopted by the Fort Worth City Council on November 6, 2018, as M&C G-19412.







Project Summary

ACTION:

An iconic light-based public art project for Pioneer Tower was recommended in the Fort Worth Public Art Master Plan Update, adopted by City Council on October 17, 2017. For this historic structure, artists' video artwork would be designed to fit the unique architecture of Pioneer Tower by utilizing a 3D scan of the structure, making it possible to project on all four sides of the tower simultaneously. On August 20-21, 2021, the premiere of the artworks will be the centerpiece for a free, two-day community event in Fort Worth's Cultural District.

In Fall 2017, the Pioneer Tower Project Core Team, composed primarily of Cultural District stakeholders, was appointed to provide input throughout the course of the project. On June 29, 2018, the City engaged local artists Joshua King (JTK Studios LLC) and Shane Pennington (SP Studio LLC), co-founders of AURORA (https://dallasaurora.com), as planning consultants to specify art infrastructure, which was installed a conjunction with the recent rehabilitation of Pioneer Tower, and to develop a production plan and budget for Pioneer Tower.

JTK Studios/SP Studio's contract has been subsequently amended to increase their scope of work to include: (1) creation of a 3D scan of Pioneer Tower; (2) guiding the Project Core Team's Curatorial Committee through a process that led to the selection of new media curator DooEun Choi and, ultimately, artists Refik Anadol and Quayola; (3) testing the art infrastructure after installation; (4) developing a plan and budget for the premiere event; and (5) testing projectors on site to finalize the layout for the premiere and to ensure the level of brightness of the projection meets the expectations of the City and the artists.

Budget

\$214,156.00 is currently available for the Artwork Implementation Agreement in the Pioneer Tower Iconic Public Art Project budget, which was approved by City Council as part of the Public Art Plan for the 2014 Bond Program and the Public Art Fiscal Year 2021 Annual Work Plan.

Staff Recommendation

The ground-breaking Pioneer Tower Iconic Public Art Project includes the most ambitious new media artworks commissioned by the City of Fort Worth to date. Based on their unique expertise commissioning and presenting largescale new media artworks to the public in an outdoor setting, as well as their invaluable knowledge and close involvement with the Pioneer Tower project from its inception, it is recommended that the Art Commission directly select* artists Joshua King (JTK Studios LLC) and Shane Pennington (Studio LLC) and make a recommendation to City Council to authorize an Artwork Implementation Agreement with to Present Projection Mapping Video Artworks by Artists Refik Anadol (Refik Anadol Studio) and by Quayola (Quayola Ltd), Commissioned by the City of Fort Worth, on Pioneer Tower, Will Rogers Memorial Center.

Staff thanked the Project Core Team for their work on this project, and informed them that since they met in December, FWPA has learned from City management that the artwork needs to be implemented more quickly.

Allen reminded all that as Core Team members on these projects they are in the unique position of acting as an Artwork Selection Panel, and previously they had made preliminary selections from the available sculptures curator Dennis Nance presented, and noted they had also suggested commissioning a local artist to create a work that is relevant to the community and speaks to our times.

Allen reminded them that subsequently, Council Member Jordan recommended revisiting the initial idea of prairiethemed mile markers for Summer Creek, suggesting replicating images created by artist Jill Bedgood for the recently installed Phase I of public art for Chisholm Trail Park, and the Core Team was receptive to this approach. It was also noted that among the artworks preliminarily selected from Dennis Nance's recommendations, the work by artist Melissa Miller fit the prairie theme that has become an important identifier for the community.

Allen said the purpose of today's meeting was to have the Core Team make recommendations to the Fort Worth Art Commission on three (3) artwork approaches for these public art projects and stated that there is sufficient funding for all three approaches: 1) mile markers by Jill Bedgood, 2) artwork by Melissa Miller and 3) commissioning a local artist to create a work.

Project Core Team members then discussed these options and asked questions of staff. The Core Team made it clear they wanted to utilize as much of the public art funding as possible within the allowable time frame, and that implementing the mile markers by Jill Bedgood and commissioning Melissa Miller to scale-up her prairie themed works seemed the most likely to achieve this. There was also a desire expressed that the works be as ambitious and impactful as the budget will allow, with a theme that would lend a sense of continuity to the neighborhood. They felt that Melissa Miller's work could create a type of gateway at the north and south ends of Summer Creek Drive, and that adding lighting to her work would be more impactful.

Peters mentioned that while the first two approaches are already part of approved FWPA Annual Work Plans, commissioning a local artist would need to be added to our 2022 Annual Work Plan, which begins October 1, 2021.

Commissioner Thompson summarized the consensus she was hearing from the group. Allen then emailed ballots to all participants. A single round of email ballots resulted in a recommendation of pursuing all three approaches if time and budget allow, with priority being assigned to the mile markers by Jill Bedgood and two gateway artworks by Melissa Miller. Commissioning a local artist is also desired if the funds remain available in FY 2022.
