Each year, the Fort Worth Art Commission recommends to City Council a Public Art Annual Work Plan for the upcoming Fiscal Year that includes in-progress and new projects based on funding source-specific public art plans previously adopted by City Council, as well as initiatives recommended in the *Fort Worth Public Art Master Plan Update*, adopted by City Council on October 17, 2017 (M&C G-19140).

An updated copy of the current *Fiscal Year 2021 Public Art Annual Work Plan*, adopted by City Council on September 22, 2020 (M&C 20-0678), which includes 50 public art projects with budgets totaling over \$13 million, is attached. Projects that are now complete are highlighted in blue. Projects anticipated to be complete by September 30, 2021 are highlighted in orange. During the Art Commission Meeting on June 21, 2021, staff will make a visual presentation that includes new public art projects recommended to be included in the *Fiscal Year 2022 Public Art Annual Work Plan*.

PROCESS

At their meeting of June 21, 2021, the Fort Worth Art Commission will consider endorsing a *Draft Fiscal Year 2022 Public Art Annual Work Plan* for the purpose of gathering public input. The commission will also set Public Hearings at their upcoming meetings to receive community input. Comments via mail or email will also be welcomed.

It is anticipated that the Fort Worth Art Commission will make a final recommendation to City Council for adoption of the *Fiscal Year 2022 Public Art Annual Work Plan* at their August meeting. A presentation to City Council may be scheduled in August or September. Once City Council adopts the *Fiscal Year 2022 Public Art Annual Work Plan*, it will become the Arts Council of Fort Worth's scope of work under their annual agreement with the City of Fort Worth to provide professional management services for the public art program.

PROJECT NAME: 2021 TEXAS-BASED CURATOR POOL

ACTION: Approve Review Committee’s Recommendation of the 2021 Texas-Based Curator Pool to Consult on Certain Public Art Projects (All Council Districts)

Summary

The Fort Worth Public Art Program created an open call for emerging and established Texas-based curators from all backgrounds, working in a variety of approaches and with diverse perspectives. Upon submission and review, curators or curatorial teams meeting the requirements would enter an application pool for consideration on future projects: they may be contacted to conceptualize, assist with the artist selection, and/or act as a project consultant for new public artworks for eligible projects of various scopes, timelines and budgets throughout the City of Fort Worth.

The purpose of this call was to provide a streamlined selection process for curators interested in assisting with public art projects throughout the city. Possible artwork opportunities include but are not limited to parks, libraries, fire stations and community centers. Curators will be selected based on creative approach and willingness to work collaboratively with other professionals and accept input from the community. Curators included in the pool will be reviewed for consideration on a case-by-case basis for specific projects.

The open call was widely advertised beginning April 22, 2021 through Glasstire.com, the Texas Association of Museums, the Texas Public Art Administrators, the Texas Artists Coalition, Arts Council of Fort Worth, and the Fort Worth Public Art Program.
