



Artist Steve Parker's Preliminary Design for Universal Playground at North Park is inspired by the universal symbols of bells and trees: bells provide solace and signify a time for fellowship; trees represent spiritual nourishment, growth, and strength. *Listening Trees* is a series of interactive musical sculptures created with colorful brass funnels, bells, and wind chimes. Each work will naturally resonate and amplify the sounds of both added elements and the natural soundscape of the park.

Parker plans to hold a series of workshops to engage neighbors in the making of the artwork, aiming to work with up to 30 participants in total. Participants would assist with the decoration of fabricated bells and chimes, to then be augmented by some of the artist's own creations to add to the visual and tonal fabric of the artwork. The format of each workshop will be based by age skill level of participants.

The artist will share further details during their Preliminary Design presentation at the Fort Worth Art Commission meeting on Monday, December 13, 2021.

Alliance Park Public Art Project Outline



The City of Fort Worth is completing construction on improvements at Alliance Park as part of the City of Fort Worth's 2018 Bond Program. Phase 1 and 2 improvements include two ponds, multiple sports fields, a multicourt, a playground with a pavilion, and other amenities. The park was identified in the Fort Worth Public Art Plan for the 2018 Bond *Program* as an impactful location for public art, reaching a wide range of visitors from across the region.

PUBLIC ART SITE AND APPROACH

This public art project provides an opportunity for an artist to create a unique stand-alone artwork(s) for Alliance Park. At their meeting, the Project Core Team expressed interest in an artwork that serves as a landmark for the area, inviting visitors into the park. They also discussed ways the work may be engaging to a diverse audience, which could include a piece that is kinetic or otherwise responds to natural elements, is participatory, or is interactive through use of phones.

PUBLIC ART BUDGET

This project is included in the Fort Worth Public Art Fiscal Year 2022 Annual Work Plan, adopted by the Fort Worth City Council on November 9, 2021 (M&C 21-0830). Funding for the artwork and contingencies, which was included in the Public Art Plan for the 2018 Bond Program, totals \$196,000.00.

SELECTION PANEL MEETING #1

FWPA staff shall present a pool of 6-8 artists. Artists will be contacted prior to being considered by the Artist Selection Panel, to ascertain their interest and availability. The Artist Selection Panel shall review the artists' previous work and qualifications and select 3 finalists and one alternate.

FINALIST ORIENTATION

The finalists shall participate in an orientation for the project which will include a virtual walk through of the site.

SELECTION PANEL MEETING #2

The Artist Selection Panel shall interview each of the three artists individually. The Panel may then ask questions about their professional experience and related work. The Panel will then recommend one artist and one alternate for the project. Upon the FWAC's approval of the Panel's recommendation, a Preliminary Design contract will be executed with the selected artist.



Marine Creek Parkway Public Art Project Project Team: Constance White, Amy Landesberg, and Jessica Bell

Constance White's Curatorial Proposal with Artists Amy Landesberg and Jessica Bell was unanimously selected by the Marine Creek Parkway Selection Panel on September 7, 2021.

On September 20, 2021, the Fort Worth Art Commission approved the selection of Curator Constance White with Artists Amy Landesberg and Jessica Bell.

The Project Team members view each other as equal partners in this increasingly collaborative project. Constance White is actively contributing to the development of the design through significant conceptual and fabrication research as well as collaborative team meetings. With her involvement in mind, the Project Team requests Constance White be considered a third artist for the project as the Team move into the Final Design Phase. White would then share copyright as a co-author of the work being developed for the Marine Creek Parkway Public Art Project.

Constance White's artist CV and recent body of work is attached for reference.

APPROVED CURATORIAL PROPOSAL (PRELIMINARY DESIGN):

Inspired by the iconic Texas star and nature including floral forms found in this area of Texas, the Project Team designed a pair of sculptures that uniquely reflects Fort Worth. Together, the works convey emerging and emergent ideas of a place in a constant state of change. One sculpture presents a sense of burgeoning movement with dynamic momentum; the other sculpture exhibits budding growth. The interplay of the two (2) stainless steel sculptures is provocative and everchanging depending on the time of day and perspective of viewers.

A Resolution of the Fort Worth Art Commission

Appointing members of the Fort Worth Art Commission and local arts professionals to serve on a Fort Worth Public Art Ad Hoc Gifts & Loans Review Panel

WHEREAS, the City of Fort Worth's public art program, commonly known as Fort Worth Public Art ("FWPA"), was established by City Ordinance in October 2001;

WHEREAS, the Fort Worth Art Commission ("FWAC") acts as an advisory board to the Fort Worth City Council related to all questions involving public art and the FWPA Program;

WHEREAS, Works of art will occasionally be offered as gifts or long-term loans to the City of Fort Worth through the Fort Worth City Council, the FWAC, and other city departments;

WHEREAS, in accordance with the guidelines contained in the *Fort Worth Public Art Master Plan Update*, which Fort Worth City Council adopted in 2017, the Gifts and Loans policy establishes a standard measure for reviewing proposed gifts and loans;

WHEREAS, the intent of the Gifts and Loans policy is to ensure that only works of the highest standard of excellence are accepted in the City's collection;

WHEREAS, the Ad Hoc Gifts & Loans Review Panel is composed of three (3) Fort Worth Art Commissioners and two (2) arts professionals from the Fort Worth community to review and make recommendations to the FWAC regarding the FWPA collection including, but not limited to, potential gifts and long-term loans of artworks to the public art collection; and

WHEREAS, on August 16, 2021, the FWAC adopted a resolution to appoint members to the 2021 FWPA Ad Hoc Gifts and Loans Review Panel for a term ending on December 31, 2021.

NOW, THEREFORE, BE IT RESOLVED, BY THE FORT WORTH ART COMMISSION OF FORT WORTH, TEXAS:

- That the FWAC appoints the following members to the 2022 Ad Hoc Gifts and Loans Review Panel for a term beginning on January 1, 2022, and expiring on December 31, 2022 ("2022 Review Panel"):
 - a. Estrus Tucker Chair, Fort Worth Art Commission
 - b. James Talambas Vice Chair, Fort Worth Art Commission
 - c. Maggie Adler Member, Fort Worth Art Commission
 - d. Giovanni Valderas Community Arts Professional
 - e. Jessica Fuentes-Community Arts Professional
- 2. That the 2022 Review Panel shall be charged with performing any of the following duties:
 - a. Review gifts and loans and other submitted materials during the year;
 - b. Convene, in person, to evaluate and discuss any gifts or loans of artwork, which may, among other relevant criteria, be based on the following criteria:
 - i. Artistic quality,
 - ii. Site,
 - iii. Context within the City Collection,
 - iv. Professional credentials of the artist; and,
 - c. Prepare a written evaluation; and,
 - d. Make a recommendation at the FWAC at a regular meeting within two (2) months after completion of the review of any proposed gift or loan.

SUMMARY

As recommended by the *Fort Worth Public Art Master Plan Update* the development of methodologies supporting collection needs ensures the integrity of the City's public art collection as an important City asset and public trust. The Plan further recommends that "the Public Art Director and the Public Art Collection Manager will establish a review process to assess the condition and needs of the collection..."

The 2022 Collection Management Advisory Panel will make recommendations that will consider:

- strategies supporting a sustainable commitment to maintain the city's public art collection
- strategies for gaining support for large scale conservation projects
- design standards for new public art projects
- other opportunities pertaining to collection management

The voluntary Advisory Panel will be made up of five (5) individuals who represent expertise in the areas of finance and Collection and Facilities Management. If panelists are not available, a list of alternatives is provided. The panel will meet at least three (3) times and shall present their final recommendations to the Art Commission in Spring 2022.
