

## PROJECT SUMMARY

Artist Joe Barrington has reached the 50% completion milestone of Cowtown Dalmatian.

- The stainless steel skeleton frame is complete with all muscle outlines placed.
- Many features including the legs, back ridge, tail, and facial features are shaped and in place.
- The horns are tapered and in place (not yet shaped).

## TIMELINE

The project is on schedule to be installed prior to the station's grand opening, expected Summer 2022.

Right: Detail of skeleton and shaped features including back ridge, tail, and legs.



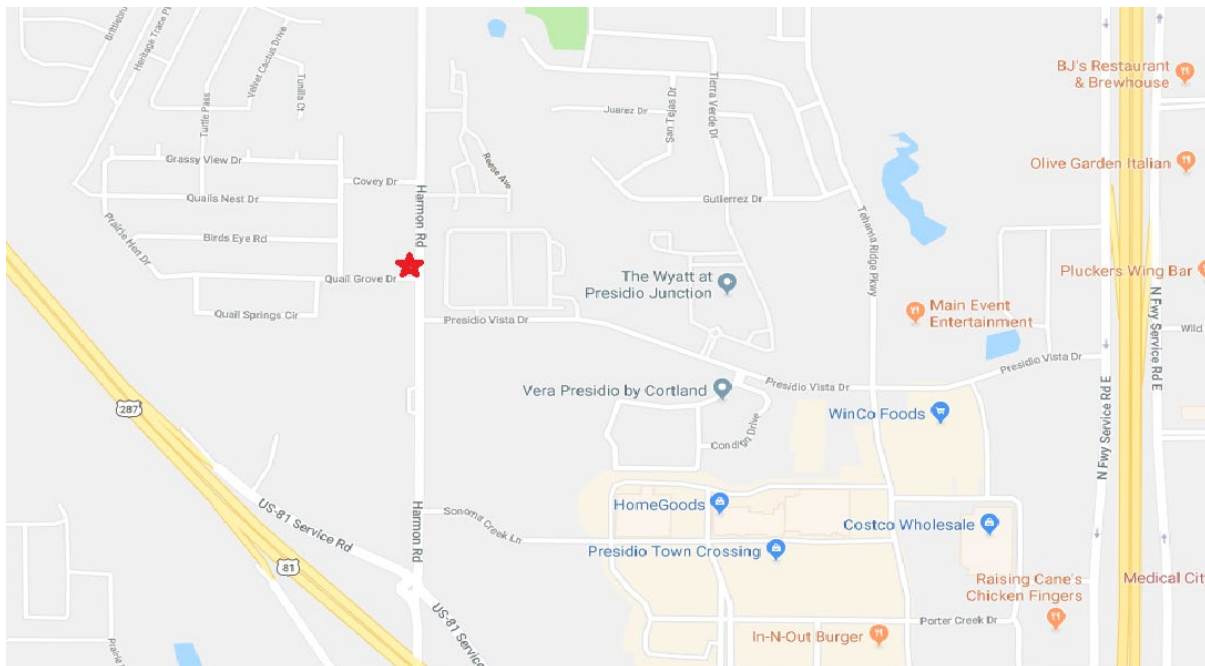

#### **HERITAGE PARK PUBLIC ART PROJECT SUMMARY**

- Art Commission approved the Project Outline on December 10, 2020
- Art Commission approved the selected artist team, Legge Lewis Legge LLC, on May 17, 2021
- Legge Lewis Legge LLC made a site visit on June 21, 2021
- Legge Lewis Legge LLC entered a Design Team Contract on July 12, 2021
- Legge Lewis Legge LLC interviews stakeholders and subject matter experts Fall 2021 / Winter 2022

#### **ARTIST TEAM SCOPE OF WORK**

Under the Design Team Contract, Legge Lewis Legge LLC, is charged with developing a public art master plan for Heritage Park that identifies: (1) Thematic approaches for public art elements that tell the stories of the site; (2) Locations, scale and types of public art; and (3) Opportunities for diverse local artists. In addition, the Contract includes compensation for Legge Lewis Legge LLC to develop a conceptual design and budget estimate for a specific artwork recommended in the Heritage Park Public Art Master Plan.

#### **STAFF RECOMMENDATION**

Due to the fast pace of the park improvement project, staff recommends that the Art Commission give approval for Legge Lewis Legge LLC to proceed with the development of a conceptual design for one of the recommended sites identified in the presentation, for the Art Commission's consideration.
