# **Artwork Budget**

\$534,500.00 from the 2018 Bond Program

Facilitator Anne Allen welcomed everyone and reintroduced the three artist finalists. The finalists (in alphabetical order) each made presentations of no more than 25 minutes, showcasing projects relevant to Gateway Park and addressing the list of prepared questions.

After all finalists had left the meeting, staff opened it up to discussion by the panel. Everyone was invited to offer their comments, and all participated in the discussion, sharing which artist they thought the best fit for the project. The panel reflected on the artwork goals for the project. The first round of voting by email ballot yielded artist Trevor O'Tool, and a tie for Alternate Artist between Agustina Rodriguez and Wowhaus. A second round of voting was done with a show of hands, and Agustina Rodriguez was recommended as the Alternate Artist.

There were comments about the wide range of work done by Wowhaus, that it demonstrates a childlike imagination and is approachable but still has an air of mystery; their professional presentation had a "wow" factor. The panel noted that the scale, playfulness, colorfulness and folksy feel of O'Tool's sculptures was commendable. Rodriguez's works are deeply thoughtful, symbolic and intentional. They commented favorably on the community engagement that is a rich part of both Wowhaus' and Rodriguez's process. Panelists remarked the park is for adults not just children and the artwork should appeal to all ages, and all three artists' work addressed that well.



# A Resolution of the Fort Worth Art Commission

Appointing members of the Fort Worth Art Commission and local arts professionals to serve on a Fort Worth Public Art Ad Hoc Gifts & Loans Review Panel

**WHEREAS,** the City of Fort Worth's public art program, commonly known as Fort Worth Public Art ("FWPA"), was established by City Ordinance in October 2001;

**WHEREAS,** the Fort Worth Art Commission ("FWAC") acts as an advisory board to the Fort Worth City Council related to all questions involving public art and the FWPA Program;

**WHEREAS**, Works of art will occasionally be offered as gifts or long-term loans to the City of Fort Worth through the Fort Worth City Council, the FWAC, and other city departments;

WHEREAS, in accordance with the guidelines contained in the *Fort Worth Public Art Master Plan Update*, which Fort Worth City Council adopted in 2017, the Gifts and Loans policy establishes a standard measure for reviewing proposed gifts and loans;

**WHEREAS**, the intent of the Gifts and Loans policy is to ensure that only works of the highest standard of excellence are accepted in the City's collection;

WHEREAS, the Ad Hoc Gifts & Loans Review Panel is composed of three (3) Fort Worth Art Commissioners and two (2) arts professionals from the Fort Worth community to review and make recommendations to the FWAC regarding the FWPA collection including, but not limited to, potential gifts and long-term loans of artworks to the public art collection; and

WHEREAS, on December 11, 2023 the FWAC adopted a resolution appointing members to the 2021 FWPA Ad Hoc Gifts and Loans Review Panel for a term ending on December 31, 2024.

# NOW, THEREFORE, BE IT RESOLVED, BY THE FORT WORTH ART COMMISSION OF FORT WORTH, TEXAS:

Staff has reviewed the Final Design Deliverables and recommends approval of the Final Design. The public art project manager (listed below) is available to answer questions prior to and during the meeting.




#### **NEXT STEPS**

# **FINAL DESIGN PREVIEW**



Bridges carry many metaphorical meanings, and the bridges along Meacham Boulevard at Polaris Drive and Painted Horse Drive mark crossings over water, a natural landscape feature the artist has chosen to celebrate. For the Meacham Corridor Public Art Project, Vicki Scuri's design includes a series of translucent fins stretching along the railings of each bridge to create a sequenced gesture that will lead motorists along the boulevard, strengthening the artistic expression into a landmark.

The colorful conceptual design utilizes seven (7) rich hues inspired by the Texas skies. The 137 fins graduate and blend through the hues of dawn and dusk, along the length of the bridges. At the center of the crossings, the vibrant greenish blue identifies the water below. The translucent material quality and colors of the fins respond to changes in light and viewing angle, maximizing the amount of sun they catch and their visibility along the road. Speed, direction, motion, and time of day will all change the expression of the art, allowing each pass to be a new experience.

The artist will share further details during her Final Design presentation at the Fort Worth Art Commission meeting on Monday, January 27, 2025.
