PROJECT SUMMARY

- The FWAC approved the New Process Project Outline, including a conceptual design proposal selection process • for Fire Station #43, on December 11, 2023.
- The Artist Selection Panel 1 meeting occurred on September 18, 2024, resulting in the selection of three finalists including Carol Acedo, Lori MacLean, and Benjamin Munoz, and alternate Demarcus McGaughey.
- Artists were placed under Conceptual Proposals Agreements prior to the Finalist Orientation on November 7, • 2024. The Artist Selection Panel 2 meeting (proposal process) was scheduled for January 15, 2025.
- On January 13, 2025, finalist Benjamin Munoz withdrew from the conceptual proposal process.
- Alternate Artist Demarcus McGaughey was contacted on January 15, 2025, and become the third finalist for the Fire Station #43 Public Art Project.
- After executing a Conceptual Proposal agreement, Demarcus McGaughey attended a Finalist Orientation on February 28, 2025.
- The Fire Station #43 Artist Selection Panel 2 meeting occurred on May 7, 2025, resulting in the recommendation of Carol Acedo, and alternate artist Demarcus McGaughey, based on their conceptual proposals.

SELECTION SUMMARY

Each artist was given up to thirty minutes to discuss their past work and present their Conceptual Design Proposal, addressing their approach to the project goals. Following the conclusion of all artists' presentations, Panelists agreed that Carol Acedo's design resonated deeply with each of them and would resonate with both community members and firefighters alike. They felt her design was simple but effective in highlighting the firefighters while recognizing the community and honoring the Walsh Ranch history. Further, they felt comfortable that her design could be implemented in a variety of ways should budget become a concern moving forward.

Panelists were excited by Demarcus McGaughey's design and felt that he had responded to the project goals in an impactful way, however they expressed some concern over legibility of the artwork from a distance. Lori MacLean's proposal was well received, but the Panel felt strongly the simpler designs prepared by Acedo and McGaughey were more effective.

Recommended Artist: Carol Acedo



Acedo's design concept intends to create a nostalgic feeling of peace and community, while honoring the history of the ranch by depicting the cattle, the green spaces, and the trees once planted by the Walsh family. It also represents the dedication of the firefighters as they watch over the community, in recognition of the risks they take to save others. The artwork consists of four stacked, backlit aluminum panels, and is mounted to the wall with space to allow for the backlighting of the Maltese Cross, a symbol of protection, courage, and self-sacrifice in the department. When the firefighters are called to duty, the lighting of the cross will change to blue to alert the community so they can support them with their thoughts and prayers. This feature embodies the cutting-edge technology that this community embraces.

Alternate Artist: Demarcus McGaughey



McGaughey's proposal tells the story of this close-knit community in west Fort Worth. Centered on the role of firefighters and service, this artwork honors the spirit of the neighborhood through family, unity, resilience, and connection. Designed to be both subtle and impactful, the piece will serve as a guiding presence—a North Star—for the

PROJECT TIMELINE

- Agreement executed with Elements of Architecture for plaque design on December 8, 2020

- Advisory Panel Meeting to review preliminary design and layouts for Auditorium Mural plaques on May 14, 2021
- Advisory Panel Meeting to review scale samples, materials, and implementation budget on June 25, 2021
- Advisory Panel Meeting to finalize size, materials, and text recommendations on July 16, 2021
- Fort Worth Art Commission Meeting to review Advisory Panel's recommendations on July 19, 2021

Nine (9) artists, selected from the *Fort Worth Public Art Pre-Qualified Artist List*, were presented to the Everman Parkway Artist Selection Panel. There was an in-depth round of viewing followed by discussion, where each panelist had the opportunity to discuss the artist(s) they felt were the best fit for the project. Panelists discussed their interest in artists who had experience in use of color, large-scale expanses, and offered conceptually rich works. Overall, they felt some artists' works were more eye-catching which may lead to a stronger artwork on such a large bridge. The voting panelists submitted an email ballot with their top three artists, resulting in selecting two (2) finalists, Susan Kaprov and Milagros. A three-way tie required a second vote to select the third finalist, Melissa Borrell. A third vote took place to confirm which remaining candidate would be the selected alternate. The Finalists will participate in a virtual orientation, after which they will prepare interview presentations. The Artist Selection Panel will reconvene to interview the Finalists and select one (1) artist and one (1) alternate artist to recommend to the Fort Worth Art Commission (FWAC) for approval for the project.
