Three finalists, Melissa Borrell, Susan Kaprov, and Milagros Collective, were chosen at the conclusion of Artist Selection Panel Meeting 1 (5/12/25). During Artist Selection Panel Meeting 2, each finalist was given 30 minutes for an interview with the panel during which they each shared a presentation on their work and responded to questions sent in advance. After presentations concluded, voting and non-voting panelists participated in a discussion about the finalists' aesthetics and the various experiences they each could bring to the project. Panelists shared their interest in Milagros Collective, particularly because of their dynamic, vibrant portfolio and experience working with diverse communities. Further, panelists were interested in the artist team's collaborative nature and practice of conducting workshops with individuals of all ages and levels of ability. Finalist Melissa Borrell was commended for how her work integrates color and light, with panelists noting her work could offer more dimensionality. Finalist Susan Kaprov's works were similarly well-received as panelists noted the variety of medium the artist had worked in and the numerous possibilities. Though panelists agreed all three finalists were strong candidates, Milagros Collective was a clear favorite due to their "fun" style and the spirit of their process overall. Panelists agreed their work is a unique blend of color and patterns that feels like a different part of the world, and they are excited about the possibilities for Everman Parkway.
