Three finalists, Brandon Burns, Falon Mihalic, and Ansen Seale, were chosen at the conclusion of Artist Selection Panel Meeting 1 (7/31/25). During Artist Selection Panel Meeting 2, each finalist was given 30 minutes for an interview with the panel during which they shared their presentations and responded to questions sent in advance. After presentations concluded, voting and non-voting panelists participated in a discussion about the finalists' aesthetics and the various experiences they each could bring to the project. Panelists discussed their interest in an artwork that would have a layered experience, making it one that could be enjoyed for years to come by park visitors of all ages. Brandon Burns's work was well received due to his ability do create experiential work that might result in different views over time. Panelists were additionally excited about his investment in the project as a hyper-local artist. Falon Mihalic's work was also well received, though some panelists felt the work was less unique and could fit a variety of project sites. They also discussed her work being more youthful as opposed to multigenerational. Ansen Seale impressed the panel with the breadth of his work and the layers of each piece presented, however some panelists expressed concern as to how he would tackle an exterior piece without architectural elements to respond to. Ultimately, majority of panelists felt Brandon Burns had the artistic versatility and the voice that would best fit the Westhaven Park project.

• The Fort Worth Art Commission (FWAC) approved the Far Northwest Library Public Art Project Outline on August 21, 2023

- The FWAC approved Susan Narduli as the artist for Far Northwest Library on October 16, 2023
- Narduli entered a Preliminary Design Contract on January 24, 2024 (CSC #60701)
- Narduli met with the Project Core Team and City staff for input prior to beginning of design on March 27, 2024
- Narduli entered a Final Design contract on September 13, 2024 (CSC #62017)
- Narduli's design has been reviewed for feasibility by the City's design consultants HKS and the Library Department's project manager


### STAFF RECOMMENDATION



### **FINAL DESIGN PREVIEW**



For the Far Northwest Library Public Art Project, Susan Narduli proposes a two-part interactive frieze that provides a multi-faceted exploration of this growing area of the City. While the formal inspiration is rooted in the architectural design of the building, the conceptual inspiration responds directly to the surrounding neighborhoods. In this newly developed area of north Fort Worth, the artwork will serve a crucial role in establishing a sense of place that reflects the current identity of the region and can evolve alongside the community over time.

The frieze will extend along the north side of two-story library wall, beginning at the entry, continuing through the vestibule. The artwork is composed of two parts that together juxtapose words, imagery and dynamic content to create a visual narrative reflective of the community's voice. The "fixed" component, a laser cut metal panel with a custom perforated surface, integrates imagery and text in a poetic representation of the regions past and present. The "fluid" interactive digital canvas reflects day to day life through a collection of imagery, community-sourced words and phrases, and a library interactive component that triggers playful animations in real time. More information will be shared during her Final Design presentation at the Fort Worth Art Commission meeting on Monday, November 17, 2025.

#### **PROJECT SUMMARY**

- 2009 Fort Worth artist Michael Pavlovsky is commissioned by friends and employees to honor the significant achievements and celebrate the retirement of long-time Fort Worth & Tarrant County YWCA Executive Director Judy Bishop
- Ms. Bishop was instrumental in the restoration of the National Register building at 512 W 4<sup>th</sup> Street, Fort Worth, 76102. She died in 2024
- 2010 Promise Fulfilled is installed at the south (primary) entrance to the building
- 2015 Fort Worth YWCA officially changed its name to Center for Transforming Lives
- 2024 The building was acquired by the city in 2025 for the new downtown library and the artwork conveyed

### STAFF RECOMMENDATION

The City has confirmed that the artwork has conveyed with the sale of the property. The public art collection manager (listed below) is available to answer questions prior to the meeting and at the meeting.

## **NEXT STEPS**

Upon approval of this recommendation, an M&C will be taken to City Council to authorize accessioning the artwork into the Fort Worth Public Art Community Legacy Collection. As part of the collection, the artwork will be eligible for regular maintenance and as needed conservation.



# **Chapel Creek Corridor Public Art Project**

## Background

- On December 12, 2022, the FWAC approved the Selection Panel's recommendation of Brenda Ciardiello and SV Randall for the Chapel Creek Corridor public art project
- On January 25, 2023, Brenda Ciardiello and SV Randall were placed under separate Preliminary Design Agreements (City Secretary Contracts No. 58862 and No. 58927, respectively)
- On January of 2023, the artists chose to collaborate on the project as a team, versus coordinating separate projects
- On February 2, 2023, the artists met with the Project Core Team for input prior to beginning design work
- Due to underground utilities making footings problematic, the artists developed a design utilizing the existing streetlight poles in the median along Chapel Creek, as preliminary engineer testing of three poles indicated they were viable supports
- On November 13, 2023, the Fort Worth Art Commission (FWAC) approved the Preliminary Design
- After approval of Preliminary Design, the artists subcontracted an engineer to test all streetlight poles identified
  as artwork supports and learned they lacked sufficient structural integrity to support the artwork designs
- Artists subsequently identified adjacent George Markos Park as an alternative location for siting the artwork, and coordinated with Parks Department staff to site the artwork elements adjacent to existing paved paths, avoiding utilities and meeting requirements for use of the Bond funding associated with Chapel Creek Boulevard

## Current Phase: Final Design


Ciardiello and Randall's goal is to create engaging and beautiful pieces of sculptural artwork to captivate the interest of the Chapel Creek area residents and users of George Markos Park. They conceptualized the artwork based on two main perspectives:

- 1. The feedback and values shared by the Project Core Team, which included an interest in the area as part of the North Texas prairie, along with other natural elements such as the beauty of the skies, storms, sunset, and native plants in the area.
- 2. The artists' own interdisciplinary practices and interests. Ciardiello's work is engaged in depicting native plants to explore the concept of what "home" is. Randal's work responds to the environment and explores the beauty of daily structures and patterns.

The artist team's final designs combine three important natural elements of the area suggested by residents: native flora, dramatic skies, and remarkable storms. Designed to be engaging and viewed from multiple angles, the unique sculptures exist in a playful space between abstraction and representation.

The artists plan to fabricate and install ten unique artwork elements within the available budget. Artwork elements will be ten feet off the ground on slim poles, fabricated in aluminum and painted with automotive paint to achieve a watercolor-like effect. Each will have an 18" diameter footing that will also act as a buffer for mowers. The artists have selected Ion Art, Austin, Texas, for fabrication and installation. The sculptures will be sprinkled at the western end of the park closest to the roadway and adjacent to the existing paved park pathways.


**PROJECT NAME:** CHAPEL CREEK CORRIDOR

"Cities gain value through public art – cultural, social, and economic value. Public art is a distinguishing part of our public history and our evolving culture. It reflects and reveals our society, adds meaning to our cities and uniqueness to our communities. Public art humanizes the built environment and invigorates public spaces. It provides an intersection between past, present, and future, between disciplines, and between ideas. Public art is freely accessible.

Data strongly indicates that cities with an active and dynamic cultural scene are more attractive to individuals and business. Public art can be a key factor in establishing a unique and culturally active place. Public art can create civic icons, but it also can transform our playgrounds, train stations, traffic circles, hospitals, water treatment facilities, and airports into more vibrant expressions of human imagination. Public art can be very visible, large permanent and unmistakable as an art experience; but it can also be very subtle, short lived or seamlessly integrated into one's experience of a place.

Public art does something that neither a public space without art nor even a museum with all its art can do; it can capture the eye and mind of someone passing through our public spaces. It can make us pay attention to our civic environment; it can encourage us to question what's around us. Art can celebrate the qualities that make one place different from another. The best of public art can challenge, delight, educate and illuminate. Public art matters."
