### **A Resolution of the Fort Worth Art Commission**

*Appointing members of the Fort Worth Art Commission and local arts professionals  
to serve on a Fort Worth Public Art Ad Hoc Gifts & Loans Review Panel*

**WHEREAS**, the City of Fort Worth's public art program, commonly known as Fort Worth Public Art ("FWPA"), was established by City Ordinance in October 2001;

**WHEREAS**, the Fort Worth Art Commission ("FWAC") acts as an advisory board to the Fort Worth City Council related to all questions involving public art and the FWPA Program;

**WHEREAS**, Works of art will occasionally be offered as gifts or long-term loans to the City of Fort Worth through the Fort Worth City Council, the FWAC, and other city departments;

**WHEREAS**, in accordance with the guidelines contained in the *Fort Worth Public Art Master Plan Update*, which Fort Worth City Council adopted in 2017, the Gifts and Loans policy establishes a standard measure for reviewing proposed gifts and loans;

**WHEREAS**, the intent of the Gifts and Loans policy is to ensure that only works of the highest standard of excellence are accepted in the City's collection;

**WHEREAS**, the Ad Hoc Gifts & Loans Review Panel is composed of three (3) Fort Worth Art Commissioners and two (2) arts professionals from the Fort Worth community to review and make recommendations to the FWAC regarding the FWPA collection including, but not limited to, potential gifts and long-term loans of artworks to the public art collection; and

**WHEREAS**, on January 27, 2025, the FWAC adopted a resolution appointing members to the 2025 FWPA Ad Hoc Gifts and Loans Review Panel for a term ending on December 31, 2025.

**NOW, THEREFORE, BE IT RESOLVED, BY THE FORT WORTH ART COMMISSION OF FORT WORTH, TEXAS:**

1. That the FWAC appoints the following members to the 2026 Ad Hoc Gifts and Loans Review Panel for a term beginning on February 16, 2026, and expiring on December 31, 2026 ("2026 Review Panel"):

The three artist finalists individually presented their conceptual design proposals to the panel and answered questions. After all finalists were interviewed, there was an in-depth discussion, where each panelist had the opportunity to discuss the artist they felt were the best fit for the project. Panelists discussed the artists' use of color, scale of the proposed artworks for the site, and how the community might engage with each. The voting panelists submitted an email ballot with their top choice of artist, resulting in selecting Kat Warwick as the project artist. A second vote was conducted to select the alternate artist, Tatara Siegel.

**Kat Warwick Design:**


Kat was inspired by words that describe firefighters and first responders, along with the current Fire Station #37 patch. Fire fighters and first responders charge toward and through danger on a daily basis. Kat chose to honor these heroic professionals by carving black marble into the form of a powerful bighorn ram charging through and emerging from billows of smoke.



Detail of Conceptual Proposal

**Tatara Siegel Design:**

“Pinned Thoughts” is conceived as a visual representation of collective voice, the project translates the immediacy of handwritten notes into sculptural form. These ‘love’ notes are dedicated to firefighters, EMS teams, and other essential community members whose labor sustains safety, connection, and mutual support. In scaling up an everyday object—the map pin and the Post-it note—the installation underscores how small gestures of gratitude can anchor a community’s emotional landscape.

## PROJECT SUMMARY

- The Fort Worth Art Commission (FWAC) approved the Gateway Park Public Art Project Outline on August 19, 2024.
- The FWAC approved Trevor O'Tool as the artist for Gateway Park on December 19, 2024.
- The artist was placed under a Preliminary Design Contract on March 14, 2025 (CSC #62960).
- The artist conducted a site visit and met with the Project Core Team and City staff for input prior to beginning concept development on June 4, 2025.
- The artist met virtually with the Project Core Team and presented four concepts for input on September 29, 2025, and subsequently chose one to develop in Preliminary Design.


## STAFF RECOMMENDATION

**PRELIMINARY DESIGN PREVIEW**

For the Gateway Park Public Art Project, Trevor O'Tool proposes a playful oversized armadillo astride a large seesaw, apparently held aloft by an unseen companion on the other end. The artwork engages visitors to the park with its approachableness, humor and larger-than-life quality. While signage will instruct visitors not to climb the artwork, it invites all nimble enough to take a seat and a selfie.

The artwork's subject speaks to a gentle, suburban animal so many are familiar with, while also taking part in the play and recreation themes that are central to the park, without celebrating a particular sport or user group, something cited as important by the Project Core Team. The artwork's location adjacent to Streams and Valley Circle Drive and disc golf will make it readily visible and accessible to drivers and pedestrians.

The armadillo will be fabricated by the artist using a clay modeling and lost wax process. Cast in sections in bronze it will be welded, smoothed and patinaed prior to transport and installation. The see saw will be fabricated in stainless steel and skinned in polycarbonate or a similar material to keep the seesaw bench from being too hot to touch in the summer. The artist has engineered the see saw and the support structure to withstand the weight of the armadillo and guests sitting on the bench. The pedestal base is designed to accommodate being in a flood plain.

The artist will share further details of the Preliminary Design during their presentation via phone at the Fort Worth Art Commission meeting on Monday, February 16, 2026.

#### PROJECT SUMMARY

- In 2009, Fort Worth Garden Club via the Moncrief Endowment commissioned Pavlovsky for an artwork honoring the philanthropic leadership of Debra Moncrief.
- The artist submitted proposal drawings for a bronze sculpture - an open circle positioned on a truncated obelisk or keyhole with high relief on both front and back of the circular shape – with two versions of relief work.
- Each of the graphite drawings are on 24" x 30" deckled watercolor paper with one featuring a display of textures, fragments, and seashells and two showing the front and back version of the commissioned artwork.
- Ultimately, the concept featuring a “lyrical scene of two figures floating above two seashells and releasing birds into the air,” a scene “reminiscent” of the classical painting *Birth of Venus* by Botticelli, was selected and the sculpture was installed on the Grand Lawn in the Fort Worth Botanic Garden.

**BUDGET**      Acquisition and framing \$2.000.00

#### STAFF RECOMMENDATION

Proposal drawings, maquettes, and studies offer invaluable educational opportunities and insight into art processes. Staff has reviewed the drawings and recommends acquiring them for the Fort Worth Public Art Community Legacy Collection as the drawings are suitable for display and offer an excellent way to promote the city's public art program.
